Six Carlisle Residents Sentenced

LEXINGTON — A federal judge sentenced the last of six Nicholas County residents involved in drug and gun crime to 18 months in prison.

U.S. District Judge Joseph M. Hood sentenced 30-year-old Jeremy Dunn on Monday for being a felon in possession of a firearm. Under federal law, convicted felons are prohibited from possessing firearms. Dunn, a felon, previously admitted to possessing a .380 semiautomatic pistol. Dunn's

twin brother, Jeffrey Dunn, 30, received 10 years in prison last week for distributing oxycodone pills in Nicholas County. Judge Hood also sentenced 45-year-old

William Padgett to 92 months for the same crime in June of this year. Three others were also sentenced for their roles earlier this year. The sentences are the result of a joint federal and state law enforcement investigation into the distribution of oxycodone pills and the il-

legal possession of a firearm in Nicholas County.

The investigation began on October 2, 2010, after law enforcement learned that Angelique "Angel" Lutes, 34, of Carlisle, had been shot in the leg during a drug related robbery. During the course of the investigation, law enforcement learned that Lutes, and her then boyfriend Jonathan "Pookie" Watkins, 39, of Carlisle, both sold oxycodone pills in and around Nicholas

County.

Both Lutes and Watkins pleaded guilty to conspiring to distribute oxycodone pills.

On February 6, 2012, Lutes was sentenced to 26 months imprisonment. On February 27, 2012, Watkins was sentenced to 43 months imprisonment. During the investigation, law enforcement learned that Gary "Bird Dog" Gammon had received a .380 caliber semiautomatic pistol from Jeremy Dunn. Both Gammon, 36, of Carlisle, and Dunn were

prohibited by federal law from possessing the firearm.

Gammon had a previous misdemeanor conviction for a crime of domestic violence. Gammon, like Dunn, pleaded guilty to possessing the .380 semiautomatic pistol. On February 7, 2012, Gammon was sentenced to three years of probation Under federal law, each defendant must serve at least 85 percent of his or her prison sentence.



The investigation was conducted by KSP and ATF. The U.S. Attorney's Office was represented by Assistant United States Attorney Robert M. Duncan, Jr.

Finances and Personnel Discussed at Recent Fire Board Meeting

Matters regarding membership and finances were discussed at the recent meeting of the Nicholas County Fire Board last Wednesday at 7 p.m.

Personnel matters were discussed at the opening of the meeting. The resignation of Johnny Parton from the position of firefighter representative was submitted to the members of the board. The recommendation was made to have Steven Minton join the board in Parton's place. Also, fire board member Tracy Brown volunteered to resign from her position as firefighter representative, and offered to be put on as an elected official under the board's recommenda-

tion. Due to regulations, the individuals wishing to become firefighter representatives will have to go before the fiscal court and be sworn in to the fire board.

Appointment of a new Chairman of the Fire Board was next on the agenda. Due to recent personnel changes, it was suggested by the acting Chairman Doug McCord that the matter of a new Chairman will be discussed once these personnel issues are resolved. The board agreed that this decision would suffice.

The next matter discussed was the chief's report, read by Nicholas County Fire Chief Doug French. According to the chief's report, there have been 16 fire runs. Of these runs, two were motor-vehicle accidents, two were struc-

ture fires, one was a rekindle, one was a grass fire, two were tree fires, 6 were downed trees due to storm damage, one downed power line due to storm damage and one alarm drop. The total cost of these runs was \$3,198. A motion to approve the chief's report was approved.

The next matter discussed during the meeting was the treasurer's report. According to the treasurer's report, the Nicholas County Fire Department has spent close to \$40,000 through the month of July. This money was spent entirely on equipment which was direly needed for the fire department. Due to some money coming back into the fire department's account, there is a current balance of \$27,293 in the account.

Carlisle and Nicholas County Firefighters and Police Departments Receive New Radios

The members of the Carlisle Police Department, as well as the Carlisle City and Nicholas County Fire Departments will now be able to communicate using digital radios.

It was announced by Carlisle City Fire Chief Phil Denton that Nicholas County and Carlisle City emergency response teams have received a total of 40 new radios. The new radios come at a cost of \$56,800 through a grant from the Federal Communications Commission.

These new radios are made to function on ei-



ther analog or digital narrowband broadcasting channels.

"These new radios are quite an improvement over our old radios," Denton said. "they have an improved range and will allow us to switch from digital to analog transmissions."

The Nicholas County Fire Department, Carlisle City Department, Carlisle Police Department and Nicholas County Sheriff's Department will all be issued the new portable radios.

Senior members of the departments will receive the newer radios,

while younger members will use the older radios until such a time when more of the new radios can be purchased. Any remaining older radios will be kept by the departments to use for spares in case of emergencies.

The radios are very helpful in the conversion to Two-Way Radio Narrowbanding, an order issued in December of 2004 which requires all Private Mobile Land Radio licenses to migrate to narrowband by January 1, 2013. Nicholas County is already in compliance with this transition.

Heaven Is A Lot Like Kentucky

"Thomas Jones was one of the party at Holder's Defeat...They saw where the Indians had made the prisoners (Hoy and Calloway) run a race, so as to leave sign to induce the whites to follow and threw down painted sticks to attract attention. John Fleming loosened his hunting shirt and clothing, and when asked why he did so replied, after seeing the pains the Indians took to court pursuit 'If we go across Licking River we shall be badly whipped!'"

Francis Jones, son of Thomas Jones and step grandson of John Fleming, in an interview now located in the Draper Manuscripts, volume 21 S.

The ancient remnants of the old Warrior's Trail on the present-day Fleming County side of the Licking River at the Upper Blue Licks were clearly visible to the handful of Kentucky frontiersmen who were following the raiding Native American warriors who had taken Jones Hoy and Jack Callaway captive from William Hoy's Station two days earlier.

The ancient trail connected the northern tribes with the southern tribes and was the route used for trade and travel across the land.

Woolly mammoths and big-horn bison wore deep ruts in the valleys and across the hills thousands of years earlier and vast herds of buffalo still used the trail system, which connected the saline and freshwater springs of the region.

They say the river actually ran red with blood on August 12, 1782 when those Kentucky frontiersmen caught up with about 70 Native American

warriors in what is now southern Fleming County, near the confluence of Sapp's Branch or Battle Run Branch, and the Licking River.

The cataclysmic events of that day, the second phase in a five phase enemy operation, would decimate the settlements of Kentucky, and are still shrouded in much mystery.

But survivors of that day have left their descendants and historians with some factual narrative of how the day's events transpired.

As the Kentuckians reached Vaughn's Ford at the Licking River, Captain John Fleming peeled off his saturated hunting shirt as he received an all-clear nod from forward scout Joseph Proctor, who had already crossed the river. Fleming sat down on a log before turning up a bottle of whiskey and drinking greedily from it in several large gulping swallows.

"It's a trap Captain Holder," he finally said after replacing the cork on the bottle and tossing it to his new best friend, the wiry little Irishman named Michael Cassidy who had just arrived on the frontier after serving on many battlefronts in the east with General George Washington. "If we cross that river we'll

be riding straight into a trap."

Holder launched into one of his famous cursing rants at Fleming's caution as he implored the men to continue onward.

Fleming bit his tongue. He understood how Holder felt and why he insisted that they continue.

These Native American warriors had abducted members of Holder's extended family; Jones Hoy and Jack Callaway, Aug. 10, from Hoy's Station in present-day Madison County. The warriors then rode northward with their two young captives.

Holder's wife was an older sister to the Callaway and an aunt to Hoy; and the family continued to lament for another older brother, Micajah Callaway, who had been captured by Shawnee warriors with Daniel Boone and several salt makers at the Lower Blue Licks in Jan. 1778.

Boone and many of the 30 salt makers had since returned. Micajah had not. It had been rumored that Micajah had "turned full injun" and Micajah was also rumored to have been one of several warriors that had tortured Col. Richard Callaway to death in March of 1780 when Shawnee warriors killed Callaway and Pemberton Rollins near Fort Boonesboro.

Fleming's own half brother, George Stock-

ton, had been similarly abducted from their Pennsylvania home in 1754 and Stockton lived for a dozen years as a famous Iroquois warrior before returning home and then later coming with Fleming to the Kentucky frontier in 1776.

Fleming thus completely understood Holder's apprehension and he listened to Holder's pleas for a full two minutes before simply mounting his horse, galloping across the river and saying loudly "I can go as far as any man in any fight."

Thomas Jones and Michael Cassidy squatted near the sand bar in the center of the river examining several painted sticks the Native American warriors had left behind. They also saw footprints along the river and knew the two boys had been forced to run the gauntlet. Jones warned the other frontiersmen of the painted sticks.

"They want us to follow Captain!" he said loudly to Holder. "They might be leading us into an ambush. We'd best not ride beyond the painted sticks."

Holder consulted further with Fleming and Capt. John Constant before dividing his force and continuing.

Half of the men moved directly north on one enemy trail while

Captain Constant and Cassidy with others followed the river trail. Soon the enemy warriors sprang their ambush with one of the first shots striking Fleming in the hip and groin and knocking him from his horse.

Cassidy and Constant heard the gunfire and raced head long into the fight from the opposite direction. Cassidy rode his horse through the entire Native American force to reach Fleming's side. He dismounted, killed a warrior, and threw Fleming onto his horse sack fashion. He then rode back through the warriors again and back across the Licking River.

William Clemmons, John Wilson, William Buchanon, John Douglas and George Johnson were killed during the valiant charge.

Jim Harper was wounded in the elbow during the charge, and although the wound was not serious, he died within two days due to complications from the infected wound.

Cassidy never received a scratch, although by some estimates over 30 shots were fired at him.

Manuel Kelley retrieved the body of William Buchanon from the battlefield, but Buchanon was shot to pieces and no longer

heard the voice of his dear friend who begged him to hold on as they rode away. Clemmons, Wilson, Douglas and Johnson, were left where they lay.

Cassidy led Fleming's horse down the dry creek bed and was pleased to see Joseph at the river. Were it not for the deadly accuracy of Joseph Proctor, who covered the retreat at the Mouth of Battle Run Branch, more would have died. Proctor had been the salvation of an earlier group of frontiersmen and his deadly accuracy had saved the remnants of Capt. James Estill's company during the maniacal Battle of Little Mountain, fought in March earlier that same year, near the present town of Mt. Sterling.

Few men on the frontier could hold a candle to Joseph Proctor when it came to marksmanship

We will join some of these same men next week in the confines of this column if the Good Lord is willing, dear reader, and we will examine the third, fourth and final phase of that deadly enemy invasion of August 1782. A month during which the legendary Daniel Boone would emphatically state, "left many orphans and widows."



Here's the Law - Stop for flashing red lights on a school bus, regardless of which direction you're headed.

- Continue your trip once the flashing lights stop and the bus starts to move.

- Violations can lead to a \$1,000 fine.

Safety Tips for Motorists

- Obey the posted speed limit.

- Fines can be double in school zones.

- Keep an eye on children gathered at bus stops.

- Watch for children who might dart across the street to catch the bus.

Safety Tips for Students

Respect your school bus driver and follow these

rules: - Stand far back when you are waiting for the bus.

- Sit still so the driver can pay attention to the road.

- Look both ways if you have to cross the street after getting off the bus, or wait for the driver to signal it's safe to cross the street.

Here's the Law: Pedestrians

- Yield to vehicles on the roadway if you cross the street at a place other than a marked crosswalk or pedestrian tunnel or crossing. If you're hit while jaywalking, the driver may not be liable, and his or her auto insurance may not cover your injuries.

- Stay on sidewalks and the right-hand side of crosswalks. Drivers are supposed to yield the right of way to pedestrians in crosswalks.

- If the road has no sidewalk, walk on the left side of the road facing traffic.

Ben Chandler Comes to Nicholas County

With the 2012 Congressional Election well under way, candidate Andy Barr and incumbent Ben Chandler have been hitting the campaign trail. With the newly re-drawn 6th Congressional District, campaigning has become difficult for both congressional hopefuls.

The redistricting of the 6th Congressional District, which now includes Fleming, Robertson, Harrison, Bath, Menifee, Wolfe, Powell, Estill, Madison, Jessamine, Fayette, Anderson, Franklin, Scott, Clark, Montgomery, Bourbon as well as Nicholas County, has placed our county in a new Congressional District. Nicholas County was previously in the 4th Congressional District (under Congressman Geoff Davis), who resigned last week.

Chandler's grandfather, Happy Chandler, was also a prominent figure in the recent history of our nation. Happy Chandler served twice as governor of Kentucky, a United States Senator and regularly crowned several Blackberry Queens at Nicholas County's annual Blackberry Festival. Among his many accomplish-

ments, Happy also served as the Commissioner of Major League Baseball from 1945 to 1951, having been inducted into the Hall of Fame in 1982. As Commissioner, Chandler approved the contract of Jackie Robinson with the Brooklyn Dodgers, which effectively began the integration of Major League Baseball.

Having been raised by a very politically conscious family, it soon became an interest of now congressman Chandler.

Chandler is a very well-known figure in Nicholas County, especially with older citizens, and has been very active in preserving the dignity and respect of Carlisle and Nicholas County citizens and

communities. Chandler has been married to his wife for 21 years, and is the proud father of 2 sons and 1 daughter, all of whom either attended or currently attend Woodford County High School. Chandler himself graduated Woodford County High School, and went on to acquire two degrees from the University of Kentucky, one being a degree in law.

Chandler enjoys the outdoors and is an avid hiker. Sports is also a big part of his life, having played shortstop and being named MVP in the congressional baseball game and being a long-time fan of the University of Kentucky Wildcats basketball team.

2002

The mayoral campaign in the City of Carlisle may be the race that attracts the most attention. Incumbent Mayor Ronnie Clark, who resides on Sycamore Street, is seeking to retain his seat for another four years, ad retired city employee Eugene Kelley, a resident of Tureman Avenue, is attempting to oust Clark and take over the leadership role as mayor of Carlisle.

Visitors to Johnson Mathers Health Care will face a different, but temporary, parking situation in the near future. The front parking lot, between Nicholas County Hospital and the JMHC Nursing Home, is to be resurfaced.

The Nicholas County Fiscal Court approved the ad valorem tax rate for Fiscal 2002-2003 at its regular meeting Tuesday night. The court chose to accept the compensating of 12.2 cents per \$100 of assessed value on real property, a reduction from the 2001-2002 compensating rate of 12.3 cents.

1997

A compromise was reached after nearly an hour-and-a-half discussion with four attorneys at Tuesday's regular meeting of the Nicholas County Fiscal Court. A main concern for magistrates and the county's insurance carrier was that having a roadway so near to the fence where the child was playing gave the insurance carrier, KaCo, "some concerns," described Flemingsburg Attorney Frank H. McCarty, previously a Flemingsburg county attorney for 13 years.

A \$400,000 federal grant will help put a sewer system at Carlisle's east end. Construction could begin

spring 1998. "It does away with a great problem - septic problems. It'll be a gig, environmental relief for them," commented Carlisle Mayor Ronnie Clark about the city's 110-120 residents to benefit from the system.

City Council looks serious this time about drawing up a curfew ordinance. Although not entirely in agreement in the particulars yet, council did discuss the legalities of and responsibilities of having the ordinance. Parents would have the key responsibility. "Those are the only ones which work," stated City Attorney Skip Watson who said he was working on research on responsibility and legalities regarding juveniles.

1992

A tentative agreement has been reached between the board of directors of The Carlisle Mercury Inc. and Park Newspapers of Morehead Inc. for sale of the Nicholas County newspaper. "Although we have agreed in principle to the purchase agreement, the final documents have not been signed as yet," said Hank bond, co-publisher, with his wife Marilyn, of The Mercury since 1987.

The Nicholas County Board of Education approved eight different maintenance projects for the schools and campus area Monday night at the regular school board meeting. Acoustical girls and boys locker room ceilings, installation of a ketch basin, sidewalk extension, painting of the gymnasium, asbestos removal and asphalt paving were many of the matters discussed.

1987

Former Carlisle Mayor Bill Power raised the question in

regards to why City Council doesn't announce extra meetings at a recent regular City Council meeting. Powers then mentioned that, if the council does not announce the meetings, then they are not legal. The extra meetings in reference over the last two years were in regards to new sewer and water projects. Most often a meeting is called when it is too late or too early to be printed in The Carlisle Mercury, and that is why Power suggested getting a notice of such a meeting to the daily paper with the widest circulation in this area.

Nicholas County Board of Education voted unanimously Monday night to raise the motor vehicle tax rate 4.9 cents, per hundred dollars valuation. The old rate of 40 cents was increased to 44.9 cents by the vote. Other options were discussed before a vote was made.

1982

Mayor Frankie Hughes received word Friday afternoon from the Gas Restoration Board in Frankfort that Carlisle will receive the \$150,000 GSRP loan to help finance the local gas restoration project. Word, in the form of a phone call, came shortly after Mayor Hughes and Don Hassall of Bluegrass ADD returned from a meeting in Frankfort with the Board.

A thirty-five cent per hour wage increase effective September 27 was announced during the Personnel Appreciation/Thorbred "Hoedown" at the Carlisle plant on Friday, August 6. The "Hoedown" was a joint meeting of all Bluegrass locations to present awards to members of the Bluegrass Thorobred Club. The club is made up of

employees who have 15 years or more service. Awards were presented to employees having 15, 20, 25 and 30 years of service.

1977

The laying of flowers by the general public at a mass grave of those who died in the "Last Battle of the Revolution" will be held Sunday, August 14 at 1:30 p.m. at Blue Licks Battlefield State Park. Interested persons are asked to bring their own flowers for this ceremony. The annual commemorative celebration is scheduled Saturday and Sunday, August 13 and 14 sponsored by the Blue Licks Commemorative Commission, Inc. Re. H. Dallas Sugg of Carlisle will give the invocation at 1:30 p.m. Sunday. He will also serve as master of ceremonies throughout the commemoration.

Thoughts from the Pastors Study

"Back to Basics"

This is the first full week of the 2012-2013 school year. Starting a new school year is an exciting yet fearful time for many, whether they are little ones starting kindergarten/first grade or seniors facing their final year before beginning a whole new phase of their lives. Parents and family members have their own concerns and aspirations as students go off to school.

For students it is time to "get back to the books" or "get down to "the business of learning". All learning is grounded on the mastery of certain basics. In Reading, that means learning the letters of the alphabet, relating the sounds that those symbols represent, and being able to put them together to form words. In Writing, the basics involved putting letters together to make words and learning to choose words to express one's thoughts. First to put together longer passages. In Math, the basics are the written numbers and the quantities they represent. You begin by counting (1,2,3...) and learning what is "one" of something. Then you can learn to work with numbers by adding, subtracting, multiplying and dividing. All higher forms of Math depend on your ability to use these basic skills.

After teaching school for 32 years I can tell you that the methods of presenting these vital foundational concepts have changed many times. No matter what the method of instruction the goal is still for every student to master these basic building blocks of all learning. Students at every level

still need to go back and review all of these basics.

The same is true for our spiritual lives. There are certain basic truths that we all must learn if we are to be the Christians God wants us to be. We begin by acknowledging who God is, the one true God who is omniscient, omnipotent, and omnipresent. God Loves us and wants us to live in fellowship with Him. It is sin that interferes with that relationship. Some sins are things that we do wrong that we know we shouldn't. "all unrighteousness is sin." (1 John 5:17). Some sins are not doing the things we know we should. "Therefore, to one who knows the right thing to do and does it not, to him it is sin." (James 4:17) in one way or another we have all sinned against God. "For all have sinned and fallen short of the glory God." (Romans 3:23) "if we say we have no sin, we are deceiving ourselves and the truth is not in us. (1 John 1:8). Romans 6:23 declares both the consequences of sin and the cure, "For the wages of sin is death, but the gift of God is eternal in Christ Jesus our Lord." It is a basic tenet of our faith that Jesus, God's one and only Son died to cleanse us of our sins. "He Himself (Christ) bore our sins in His body on the cross, that we might die to sin and live to righteousness; for by His wounds were you healed." (1 Peter 2:24) Jesus Himself said,

"For the Son of Man has come to seek and to save the lost." (Luke 19:10)

God invites us to restore our fellowship with Him through the blood of Jesus. "Draw near to God and He will draw near to you, Cleanse your hands, you sinners, and purify your hearts you double minded." (James 4:8) After Peter had preached the first gospel sermon the people asked, "What must we do to be saved?" he replied, "Repent and let each of you be baptized in the name of Jesus Christ for the forgiveness of your sins; and you will receive the gift of the Holy Spirit." (Acts 2:28)

We need to get back to the spiritual basics. Having been in ministry for over 37 years now, I can say that the methods of presenting the gospel and worshipping have changed in many churches. No matter what the methods, the message has not changed. The Word of God reveals to us the absolute truths that were the basics of our faith. God loves us and wants us to be saved. Sin separated us from God. Jesus Christ died to pay the price for our sins. Because of what He did, we can have a hope of eternal life. This hope is ours if we will accept Christ as Savior and make Him the Lord of our lives. Let us all get back to basics and get back to God.

The next event, the


Buggy Class, was awarded to Mike Eldridge, the only competitor.

searching Wagoner genealogical records and, at the last count, there were 2,096 entries in his computer, representing 715 marriages.



Cynthia Young, of Edward Jones Investment discusses importance of investing at Brown Bag Meeting

Cynthia Young, Financial Advisor from the local Edward Jones Investment Firm, discussed the history of the Edward Jones company as well as the importance of investing at the recent Brown Bag lunch at the Neil Building last Friday.

First, Young gave the crown some background history about Edward Jones. The two teams met around the same time last season. In 2011, Lewis County held off the Jackets 33-30 in a season-opener.

Robert Hopkins-coached Nicholas County got in some work over the weekend, competing in the Eastern Kentucky Conference (EKC) Grid at East Carter. So did Lewis County. The Jackets battled host East Carter while Lewis County faced Fairview in a battle of defending district champions.

Lewis County is the reigning Class 3A, District 6 champion. The Lions defeated Russell and Mason County during the 2012 season to clinch the title.

Lewis County is picked to finish second behind Russell in the Preseason Class 3A, District 6 Poll. The Lions are listed ahead of Fleming County (4-7), Mason County (3-8), West Carter (3-8) and East Carter (0-10).

Head coach Josh Hughes has helped to transform Lewis County into a consistent winner. The Lions enjoyed a historical season in 2011. A senior-laden team led the Lions to eight wins opposed to only three losses.

After opening the season with the hard-fought victory over Nicholas County, Lewis County’s campaign concluded with a loss to Powell County in the opening round of the Class 3A State Playoffs. Powell County pummeled the Lions 45-0.

Despite the lopsided loss in the postseason, Lewis County managed to outscore opponents

210-167. The Lions exited the season ranked 10th in the final Class 3A Standings.

Nicholas County is fresh off a successful season of its own. The Jackets finished the 2011 season 7-5. Nicholas County defeated Allen Central in the opening round of the Class A State Playoffs before bowing out to district foe Fairview.

Nicholas County will look for a new offensive leader or two to emerge. The Jackets lost leading rusher Caleb Pope to graduation and quarterback Dalton Pope to a transfer to neighboring Bourbon County.

Nicholas County is picked to finish third behind Raceland (6-6) and Fairview (12-1) in Class A, District 7. The Jackets are limited one spot ahead of Paintsville (2-9) in the preseason district poll.

Nicholas County, which won five straight games last year, finished the 2011 season ranked just outside of

the Class A Top 10. The Jackets were ranked 11th in the final Class A Standings.

Nicholas County outscored opponents 407-306 during the 2011 season.

In the nightcap of the Montgomery County Rec Bowl, host Montgomery County will entertain Rowan County.

Montgomery County concluded the 2011 season 5-5. The Indians compete in Class 5A, District 6, which also features state finalist Anderson County (12-3), Franklin County (11-1), East Jessamine (5-6), Woodford County (6-4) and West Jessamine (1-9). Montgomery County is picked third in the Preseason Class 5A, District 6 Poll.

Rowan County ended last season 8-3. The Vikings are picked to finish third in Class 4A, District 8, behind Johnson Central (9-3) and frontrunner Ashland (9-3), ahead of Boyd County (5-6) and Greenup County (0-10).

Ordinance No. 12-3
AN ORDINANCE AMENDING CQOE OF ORDINANCES 5; 03 Summary

This Ordinance amends Code of Ordinances 51.02 (A) to change date bill is due before disconnect for non-payment.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF MT. OLIVET, KENTUCKY as follows:

Code of ordinances 51.02 (A) hereby amended to read in its entirety as follows: 51.02

Disconnection for Non-Payment

(A) It is the policy of the city-to discontinue utility service to customers by reason of non-payment of bills only after notice and a meaningful opportunity to be heard on disputed bills. The city's form for application for utility service and all bills shall contain, in addition to the title, address, room number, and telephone number of the official in charge of billing, clearly visible and easily readable provisions to the effect:

- (1) That all bills are due and payable on or before the 10th day of each month;
- (2) That if any bill is not paid by or before that date, a late charge will be assessed by the 10th day of that month. Bills not paid by the 20th of the month due service will be discontinued for non-payment. A reconnection fee of \$25.00 will be due and a new deposit will be required.
- (3) In the event a occupant moves from rental property it will be the landowner responsible to pay the bill along with the reconnect fee and a new deposit.
- (4) That any customer disputing the correctness of his or her bill shall have a right to a hearing at which time he or she may be represented in person and by counselor any other person of his or her choosing and may represent orally or in writing his or her complaint and contentions to the city official in charge of utility billing. This official shall be authorized to order that the customer's service not be disconnected and shall have the authority to make a final determination of the customer's complaint.

(B) Requests for delays or waiver of payment will not be entertained; only questions of proper and correct billing will be considered. In the absence of payment of the bill rendered or resort to the hearing procedure provided herein, service will be discontinued at the time specified.

(C) When it becomes necessary for the city to discontinue utility service to a customer for nonpayment of bills, service will be reinstated only after all bills for service then due have, been paid along with turn-on charge in the sum of \$25 and a new deposit.

Control of Backflow and Cross - Connections

The purpose of the subchapter is:

(A) To protect the public potable water supply served by the City of Mount Olivet, Kentucky, from the possibility of contamination or pollution by insulating within the customer's internal distribution system(s) or the customer's private water system(s) the contaminants or pollutants that could backflow or backsiphon into the public water system;

(B) To promote the elimination or control of existing cross-connections, actual or potential, between the customer's in-plant potable water system(s) and nonpotable water systems, plumbing fixtures, and industrial piping systems; and

(C) To provide for the maintenance of a continuing program of cross-connection control that will systemically and effectively prevent the contamination or pollution of all potable water systems by cross connections.





country that work with low-income individuals and communities earn the CCAP designation after demonstrating their Community Action acumen by completing a detailed assessment of their knowledge of poverty theories, causes, and remedies; ability to help low-income people achieve economic stability; and comprehension of the mission, vision and values of Community Action. To date, there are 442 CCAPs across the country representing rural, urban, and suburban Community Action Agencies.

Established in 1993, the CCAP program provides a structured and focused procedure for Community Action leaders and managers to prove their mastery of a wide-ranging body of knowledge covering theories on the causes and remedies of poverty and to assess how they are helping vulnerable people achieve economic security. Their understanding and comprehension of Community Action's history, vision, and values are also measured. In

order to successfully complete the process, individuals are required to provide an extensive record of their management and leadership skills and involvement in anti-poverty initiatives on the local, state, and national levels; develop a portfolio highlighting their education, training, and accomplishments, and pass a written exam.

Schalch has been employed by Community Action Council for Fayette, Bourbon, Harrison and Nicholas Counties for 13 years and is a resident of Robertson County.
