Kentucky State Police are investigating a number of acts of arson around Nicholas County following

Nicholas County Sheriff Jeff Sidles confirmed on Monday morning that at least three fires that

It is no secret that Nicholas County has been plagued with what some would call a "drug epidemic." Drugs have been confirmed to have been responsible for countless deaths and illnesses, not to mention the destruction of countless of lives. Carlisle PD makes drug arrest

The Carlisle Police Department received a call Friday evening around 8:30 p.m. of a drug deal in progress at Crockett's IGA. Officer Shane Adams responded to the scene, pulling over a 1997 Ford Ranger on Moorefield Rd.

The driver, Michael Poe, 34, of Dunn Rd., was unable to produce a valid insurance card. Adams told Poe that he had stopped him because someone saw him take part in a drug deal. Poe replied that it was a lie. Adams requested a search of vehicle, and Poe consented and said he would find nothing.

A search of the vehicle produced a snort tube and a spoon, and a search of Poe's person revealed rolling papers and a green leafy substance that Adams said he believed was marijuana. Poe said that it was a "bag of dope."

Poe was arrested and charged possession of marijuana; drug paraphernalia – buy/possess; failure to produce insurance card; and improper/ no windshield.

Poe was lodged in the Bourbon County Detention Center where he remains under \$1000 full cash blanket bond.

Nicholas man charged with stalking, trespassing

A Nicholas County man was arrested last Monday on a warrant for stalking charges.

Jeff J. Farrow, 29, of 5393 Moorefield Rd., Carlisle, was arrested on Monday, June 11, on East Main St. by Carlisle Police Officer Scott Johnson.

The warrant charged Farrow with stalking, 2nd degree; criminal trespassing, 2nd degree; and criminal mischief, 3rd degree, for alleged incidents on June 9.

The warrant stated that the victim, identified as Kinley Blades, discovered Farrow on the roof of her house near her bedroom window around one in the morning.

"Defendant had been duly warned by victim and Carlisle City Police officers earlier in the week on Wednesday, June 6, to vacate the premises and to take all his belongings, which he did," the warrant said.

The warrant went on to say that Blades and Farrow had a relationship and had lived together for nearly eleven months prior to the incident.

Blades said that Farrow had been mentally and physical abusive to her. The warrant stated that she had to ask him permission to go to work and that he had dragged her down the driveway, choked her, struck her, and held her captive. It also said that he had "texted victim an exhorbitant number of times demanding to know her whereabouts and business."

The warrant also said that Farrow had caused damage to siding on the residence and other personal property of Blades when he descended the roof. Farrow was also in possession of a firearm.

Farrow was lodged in the Bourbon County Detention Center under \$2500 bail, secured by cash. He was directed to have no further contact with Blades, to no longer possess weapons, and to commit no further offenses. Farrow was released on

Court approves contract for sale of country club

The Nicholas County Fiscal Court took action on several items of county interest including approving the contract for the selling of Carnico Country Club during their recent meeting. Real estate agent Mark Mattox addressed the court to explain the process of the selling contract and the related fees.

July 10 is the proposed date for the sale of the building.

The sale will be properly advertised in local and area newspapers, with a buyers premium of 6%. The court will only be responsible to pay for the advertising fee. The court members granted the advertising placement to be under the discretion of the County Judge Executive Kenny Lyons and the listing agents.

Lake Shore Restaurant is under a month to month lease through the court. With the approval of selling Carnico, Lakeshore owner Brad Marshall stated that their last night will be June 23rd. Their liquor license expires and Marshall said he just couldn't justify paying \$1200 to renew them for a couple of days.

Mattox stated that the real estate will sell first and then the equipment. Mattox explained his logic that the person buying the building could be interested in opening a restaurant and might want to purchase the equipment. If the equipment is purchased separately the buyer will have approximately two weeks to remove their purchase from the property.

County Attorney Dawn Letcher explained to the court that she has examined the contract and thinks it is fine. A motion to approve the contract of selling Carnico Country Club was made by Jimmy Wells, seconded by Steve Hamilton, motion passed unanimously.

A motion was made by Jeff Randolph, seconded by Mike Webb, to allow Rodney Hatton to remain in the lower level of the club to keep maintain the golf course. Once the sell is final, Hatton will need to work out with the owner an agreement. The motion passed.

The Court was presented with the Tax Settlement for 2011. Approximately 96% of the taxes have been collected. There is a second letter from the County Attorney going out for the uncollected taxes. Motion was made by Magistrate Mike Webb, seconded by Mitchell, Tax settlement was approved unanimously.

Sheriff Jeff Sidles asked the court for approval to apply for the Cleft Fund grant, the fund is to help pay for the deputies and police officers. Sidles is allowed up to \$3,100 per year for helping fund the pay for the deputies and police officers, according to discussion during the meeting.

"There are other counties that have been receiving this such as Bourbon, Fleming and other surrounding counties." Sidles stated, "I will have to put polices in place."

Once approved for the fund it will reimburse for where Deputy Snedegar was hired. To be eligible for this fund the deputy/police officer has

The Fiscal Court unanimously agreed that they felt the fund was good, and agreed with Sheriff Sidles to go ahead and pursue the fund.

Letcher responded that the contract was legitimate and was for only 12 months, and for no more than \$5,000, possibly much less. This 911 contract is to help update the 911 map system so the emergency responders are able to locate each physical address in a time of need. A motion was made by Jeff Randolph, Seconded by Steve Hamilton. The motion passed unanimously.

Leadership Gap: Too Little Rest and Renewal

Conversations with leaders from various walks of life, including Christians active in the church, indicate that generally, across the board, those with the greatest responsibilities in our society do not get enough rest and do not feel renewed. Instead, they operate in a world of daily stress, not feeling there is even enough time to replenish on weekends, or with regular vacations/ retreats. Their families are often affected, and they sometimes lose the passion for the work they enjoyed earlier in their careers. The technology they have access to often only adds to the problem—creating more work. not less. What do these vulnerabilities mean to these individuals, their organizations, and the relationships in their lives? Perhaps much more than is noticed, until years have gone by without relief. Thus, sadly, many talented people, from various vocations and backgrounds, are in the prime of their lives, but already burned outalready counting the days until retirement (and suffering mental, emotional, physical,

spiritual, and relational damage). Recommendations

For the over-

worked and stressed leader, there is hope. And in many cases, the solutions are relatively simple to implement. Here is a sample list of strategies:

Take the time to audit a typical work week, identifying daily sleep habits, overtime at work, down time with family, hobbies, and time for social relationships. Then, make adjustments.

the Audit monthly and yearly cycle. How much actual time is being set aside for vacation, retreat, and renewal? Again, make adjustments Renew the daily cycle at work by re-focusing on relationships as the top priority. Work for balance every day, including paying attention to nutrition and exercise habits. Most important, steal away daily for quiet time and reflection. Renewal and internal healing/ wellness begins with prayer and some uninterrupted time in the Scriptures, and becoming still enough to listen to God as he speaks to us. Jesus spoke often of the need for wholeness in one's life. In Matthew 11:28, He says: "Come to me, all you that are weary and are carrying heavy burdens, and I will give you rest." (NRSV). May we accept His invitation, and find the balance that allows us to live life with abundance. And, this holistic health will include plenty of 'rest and renewal'.

Mattox discusses local development at Chamber's Brown Bag Forum

This month's Brown Bag Forum at the Neal Welcome Center, sponsored by the Carlisle Chamber of Commerce, had local real estate agent Mark Mattox speak about the local real estate market and Carlisle's future potential for development.

Mattox Real Estate has been a fixture in Nicholas County for many years, getting his start with Earl Hamm in 1981. Customers travel from all around to attend antique auctions at his business on U.S. 68, and Mattox sells real estate around the area and across central Kentucky. The Internet has allowed Mattox to expand his business worldwide, and he recently opened a new office in Paris.

Mattox said that Nicholas County currently has 67 properties on the Multiple Listings Service (MLS) with the Lexington Board of Realtors. So far this year 7 properties have been sold. Properties were listed between \$18,000 and \$300,000, and they sold for between \$35,000 and \$142,000.

"There's not much of a middle ground, and most of our houses are middle ground," Mattox said. "We have to be more aware of the rest of the market and more aggressive in how we track things."

Mattox said that most of the buyers for these properties were local, and that attracting outside buyers is a problem. When asked to specify why, Mattox said that while prices are attractive to out of town buyers, they tend to be turned away by two things: the lack of care on surrounding properties, and the lack of employment options.

"They don't want to be faced with anything that would be detrimental to their property values," Mattox said of potential out of town buyers.

He added that the real estate problem is

something affecting the middle class across the county. "The middle class has lost 39% of its net worth" since 2007, most of which is in real estate.

Mattox was asked if any commercial developers were looking at the area. "There are no speculative developers around here. The same was true 25 years ago," he said. He added that many other small communities are looking for exactly the same thing.

This led to a general discussion of how to make Nicholas County and Carlisle more attractive to outside investment.

"We can tell them it's a good place to live and to work, but they have to see that for themselves," Mattox said.

Mattox said that planning and zoning regulations are necessary to making the area an attractive market. He also said that any communitywide beautification program was also beneficial.

He said the commu-

nity has many good selling points, including the hospital, the nursing home, and the school system.

A number of audience members expressed concern that the deteriorated store fronts in downtown Carlisle detracted from potential development.

Mattox responded that the obvious problem was finding someone willing to come in put up the money for restoring and rebuilding them as well as finding people who are interested in preserving history.

Following Mattox's talk, Judge Executive Kenny Lyons announced that Rep. Sannie Overly will be in town at the Neal Building next Monday, June 25, at 3 p. m. with other community leaders to discuss the U.S. 68 project in Nicholas County.

Bob Garvin also noted that the Nicholas County Historical Society is attempting to raise \$1000 toward the renovation the upstairs portion of the Neal Center.

The next Brown Bag Forum is scheduled for Friday, July 13, at noon at the Neal Welcome Center. The public is invited.

Nicholas County Fiscal Court members are looking to improve the county's equipment and last week they approved to request for advertisement of sealed bids on purchasing a backhoe.

Magistrates Mike Webb and Steve Hamilton presented the court members with numerous quotes on a backhoe that has been up for discussion a couple of months ago. The court has agreed to purchase a backhoe for the county road department, after some research Webb and Hamilton received the following quotes for a backhoe. Wilson Equipment has a couple of used 2009 Case 580 SM four wheel drive 795 hours, for \$66,500.00, 2004 580 SM with 5465 hours for \$26,500, new ones are a 580 N Case with freight and shipping \$68,570.94 or a 580 SN Case freight and shipping \$69,082.60,

Jackie Randolph has a 2004 580 SN Case with 2500 hours for \$39,000. Webb looked online for a used backhoes and found a 2004 580 SM with 3207 hours for \$41,500. The court decided that they would ask for bids on a backhoe to see what was out there, with a stipulation that the court could decline the sealed bids and decide to go with one of the above or as they saw the best option to go with. A motion was made by Jimmy Wells, seconded by Steve Hamilton. The motion was approved by all.

Some of the old business from past meetings was a topic of discussion for the meeting this month. Magistrate Jeff Randolph asked the other magistrates and the judge if getting 2 bids for the repairs of the Old East End concession stand. All members of the court agreed that would be okay.

LOCAL NEWS Lawmakers learn progress of sorghum-to-ethanol project

CARLISLE, Ky.— Brazil is doing it; so are places in Florida and Texas.

And now retired IBM chemical engineer and Southeast Biofuels President Stephen Popyach, of Mt. Sterling, wants Kentucky to invest more in production of ethanol using sorghum as feedstock.

"Most foreign countries that want to become energy independent are growing sorghum right now," Popyach told the Interim Joint Committee on Agriculture and Small Business at Blue Licks State Resort Park yesterday. Popyach said 700 gallons of ethanol can be produced with an acre of sweet sorghum, a plant that is similar to corn and grows well, even in poor soil.

Southeast Biofuels has finished the first phase of a project that resulted in production of a million gallons of ethanol from 2,000 harvested acres of sweet sorghum, Popyach said. Passed among committee members were a dry, dense sorghum stalk, a glass jar containing juice pressed from sorghum feedstock, and a smaller jar containing ethanol made from the juice.

It takes 10 million gallons of the juice to make a million gallons of ethanol, Popyach said.

No funding is yet available for the proj-

ect's second phase, which Popyach expects to cost around \$400,000, he told lawmakers.

"Phase II is to actually prove to the farmer that we actually have a working unit sitting on a farm," Popyach said. "That is what we're trying to do."

Current plans are for Southeast Biofuels to develop a unit that can fit on one tractor trailer and produce 250 gallons of sor-

ghum ethanol a day or 90,000 gallons a year—on the farm, he said. Each unit will be modular, mobile, and require 200 acres of sweet sorghum for production, he said.

In keeping with the company's plans to make ethanol production possible "on the farm", Popyach told lawmakers that producing ethanol from sorghum is not a very complex process. "It's not hard to do.,"

he said.

Making it possible for farmers to refine their own fuel on the farm will not only eliminate transportation costs required to moving fuel from Point A to Point B, but Popyach said the cost to make a gallon of ethanol from sorghum on the farm is affordable at around \$1.60. The ethanol, which is a fuel additive, can also play a role in Kentucky's goal of energy independence, Popyach said.

The general fund is used for administrative, property maintenance, insurance, utilities, wages and funding of the ambulance service, jail fund, convenience center, animal control and other non taxing organizations. When Jockey closed, the general fund took the hit from the loss of occupational taxes and property taxes. I think that tax amounted to about 90,000.00. This is a big loss too all of us. I hope this answers some of the questions on our budget without being more confusing.

Grand jury issues indictments By Charles Mattox News Editor

A young man has been indicted on 19 criminal sex charges by members of a Robertson County Grand Jury.

Timothy Hall, 19, was indicted on seven counts of sodomy, second degree; three counts of sexual abuse, second degree and nine counts of possession of matter portraying a sexual performance by a minor.

Hall was also indicted on one count of possession of marijuana.

indictments The against Hall allege that the crimes occurred between Sept. 1, 2011 and Jan. 11, 2012, according to the indictments. Hall allegedly had "deviate" sex with a female juvenile, and possessed explicit photographs of a juvenile female.

Hall's bail was set at \$10,000, according to the indictment.

Hall's indictments were issued following the testimony of Kentucky State Police Trooper Charles Haselwood.

Tracy Hester, 40, had two separate, multicount indictments issued against him following the testimony of Robertson County Sheriff Randy Insko and Kentucky State Police Trooper Jason Ritter.

According to the indictments, on Oct. 2, 2011, in Robertson County, Hester allegedly committed four counts of wanton endangerment, first degree, when he "created a substantial danger of death or serious physical injury to Keith Ellis by ramming his vehicle into

Mr. Ellis's vehicle (twice on KY 165 and twice on Mann Road), according to the indictments. Hester was also indicted on the charge of criminal mischief, second degree for his alleged actions on the same day, when he allegedly "intentionally damaged or destroyed property belonging to Keith Ellis."

Hester also received multiple indictments for his alleged actions on April 6, 2012.

According to the grand jury indictments against him, Hester committed indicted on the charge

Frankfort Focus

Although most of the public attention the General Assembly receives is early in the year, when legislative sessions are held, there is considerable amount of work done during the remainder of the year as well.

No bills are voted on during this time, which is known as the interim, but the 15 joint House and Senate committees, plus more than a halfdozen other committees and task forces – use this time to get a clearer understanding of the issues affecting the state and what more we could do to help.

These interim meetings began several weeks ago, and while most are held in Frankfort, there are times when other communities serve as host.

That happened last week, when the General Assembly's Agriculture Committee, which I co-chair, came to our legislative district. Its meeting was held at Blue Licks Battlefield State Resort Park, where one of the topics was on a potential addition to our biofuels industry: sorghum.

The presenter said about 700 gallons of ethanol can be made from an acre of sorghum, which can be raised much like corn and in poorer soil as well. His company has already produced a million gallons of ethanol – it takes 10 gallons of sorghum juice to make one gallon of ethanol – and he said refining equipment could be used on the farm to produce fuel right there at a cost of about \$1.60 a gallon. It is not a complex process either, he added.

During the remainder of the meeting, the committee also heard from those affiliated with the University of Kentucky's College of Agriculture. The highlight was a report from a student who detailed her research behind the germination of seeds and how a better understanding could improve agriculture.

In another presenta-

tion, committee members learned more about the positive impact the tobacco settlement has had on Robertson County over the last dozen years. The cattle industry has especially benefited there.

Although it was not part of our committee meeting, I learned earlier this month that nearly \$700,000 has been awarded to more than 80 farms this year as part of an energysaving program, which is funded with \$2 million in tobacco settlement money set aside in January. For those who are interested, deadlines to apply for the remaining money are scheduled to come at the end of this month

and the final day of both September and December. If you need more information, please contact the Governor's Office of Agricultural Policy at (502) 564-4627 or, if you are online, send an email to: govkyagpolicy@ky.gov.

This will build on the success our farmers saw from a similar program funded federally between 2009 and 2011. More than \$1.4 million was invested in 190 farm projects during that time, which in turn generated \$2 million in energy savings.

As you can see, information like this may not always come up during a legislative session, but it is vitally important just the same. As summer gets underway, these interim committees will continue investigating other issues as well. I will continue updating you periodically on what we find.
