Fire bill hot topic at City Council Meeting

Tensions were high at Monday night's regular meeting of the Carlisle City Council as news of anticipated legal action against Nicholas County Fiscal Court was the topic of discussion.

Mayor Kevin Booth had previously disclosed that he would be suing Nicholas County Fiscal Court for the services performed by the Carlisle City Fire Department in the wake of the resignation of several members of the Nicholas County Fire Department.

A bill in the amount of \$4,615 was being charged to the Nicholas County Fire Department for the reimbursement of their services. This price includes equipment usage, truck rental and the paying of employees.

Jay Moreford and Tracey Brown were present at the meeting as representatives of the Nicholas County Fire Department to gain some clarification and to openly discuss the bill with Mayor Booth.

"First off, I want to say that I do appreciate the assistance we received from the City Fire Department," said Moreford. "At that time, we were in need of assistance due to the circumstances. The fact that you stepped up to help us out really means a lot."

"In the case of this bill," Moreford continued. "I just think that we need to sit down and work this out. We're all here to serve the city and the county and fighting about it doesn't bode well for anybody."

Moreford also commented on the alleged comments made against City Fire Chief Jim Biddle.

"As far as I know, no one said anything negative to Mr. Biddle," said Moreford. "But if there was anything said that might be considered derogatory, I sincerely apologize."

At this point, Biddle interjected.

"I was at the meet-

ing where everyone resigned," explained Biddle. "While I was there, there were some board members that acted unprofessional towards me. I'm doing the best I can in my position and I don't feel that I deserved to be treated in such a way."

Upon hearing this, Moreford sincerely apologized and the matter of the bill was discussed further.

After hearing Moreford's comments, Mayor Booth decided to speak on the matter.

"It's my opinion that we don't need to get together and discuss this," stated Booth. "The bill is what it is. I have a city fire department that desperately needs equipment in order to move forward."

Moreford retorted Booth's statement.

"I would really like to stay out of court with this bill," said Moreford. "We were informed that it was our responsibility to make sure that this

bill is paid."

Booth then commented on the true responsible party of the fire bill.

"Due to a contract between the City of Carlisle and Judge Kenny Lyons, the Fiscal Court is responsible for the payment of this bill," said Booth. "The Fis-

cal Court was presented with the bill and did not pay it. They told Chief Biddle to present the bill to the County Fire Department. Our concern lies with the Fiscal Court paying this bill, as they promised."

Upon hearing this information, Moreford

stated that he did not know that was the case.

"I just hope that we can get this behind us and move forward as a community," he said.

Carlisle man charged with rape, burglary

A Nicholas County man was arrested Monday evening on rape and burglary charges.

Gabriel L. Foster, 20, of Tureman Ave. in Carlisle, was arrested Monday by Carlisle Police Officer Scott Johnson.

The arrest citation stated that Johnson interviewed Foster, who

admitted that he had taken a Nintendo 3DS game system and had pawned it.

Foster also said that he had been with a female juvenile, who had entered two residences with the intent to steal jewelry. He admitted to having had sexual relations with the juvenile

on several occasions.

The citation stated that the stolen property was pawned in Cynthia and Mt. Sterling.

According to Sheriff Jeff Sidles and the arrest citation, the stolen property was located at Layton's Pawn in Mt. Sterling.

Foster was arrested and charged with one count of rape, 3rd degree; one count of burglary, 2nd degree; and receiving stolen property, under \$500.

Foster is currently lodged in Bourbon County Detention Center, where he is being held without bond.

The Carlisle Mercury will continue to follow developments in this case as they become available.

Small earthquake rocks Eastern Ky., surrounding states

What was that? This was the popular question around Nicholas County on Saturday afternoon approximately 12:14 p.m. Residents all around Nicholas County and surrounding counties felt a tremor that lasted around 3-4 seconds. The tremor was felt throughout the Eastern part of Kentucky to Knoxville, Tennessee and parts of Ohio.

An earthquake occurred in Letcher County, just west of Whitesburg, with officials from the U. S. Geological Survey

stating that it measured a 4.3 on the Richter scale. No damage was reported locally, just a great deal of people feeling the tremor, hearing the roar, and some noticing items in the household shaking.

The largest earthquake to strike the area in recent decades was one in Bath County, near Sharpsburg, in July 1980, registering 5.2 on the Richter scale. Another small earthquake registering 3.5 occurred along the same fault line in Bath County in September 1990.

Kentuckians felt a 5.8 earthquake that was centered in Virginia in September

2011.

Earthquakes are created by the shifting of the earth, causing the tectonic plates to be positioned in a bind. Once they are able to release the pressure, an explosion-like reaction from the expansion of the fault creates a tremor known as an earthquake. Scientist measures an earthquake by the intensity of the tremor.

Whitesburg and the surrounding area suffered from some damages, including a cracked foundation to the Letcher County Courthouse, breaks in gas and water lines, and electrical outages.

Crises there will continue to be. In meeting them, whether foreign or domestic, great or small, there is a recurring temptation to feel that some spectacular and costly action could become the miraculous solution to all current difficulties. A huge increase in newer elements of our defense; development of unrealistic programs to cure every ill in agriculture; a dramatic expansion in basic and applied research -- these and many other possibilities, each possibly promising in itself, may be suggested as the only way to the road we wish to travel.

But each proposal must be weighed in the light of a broader consideration: the need to maintain balance in and among

national programs -- balance between the private and the public economy, balance between cost and hoped for advantage -- balance between the clearly necessary and the comfortably desirable; balance between our essential requirements as a nation and the duties imposed by the nation upon the individual; balance between actions of the moment and the national welfare of the future. Good judgment seeks balance and progress; lack of it eventually finds imbalance and frustration.

...In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.

I hope all veterans and those currently serving their country in the military were able to have some free time this weekend and appreciate Veteran's Day, 2012.

Communities across

the areas covered by the Kentucky News Group held a variety of celebrations honoring area veterans during the weekend and on Monday.

For the last few years I've made it a point to attend the Veteran's Day celebration hosted by the students and staff of Flemingsburg Elementary School (FES).

The halls of the school are decorated with photos of Fleming County veterans and family members who have served their country that are related to the students of FES.

Good patriotic music was sung by school children, including *God Bless America* and *America the Beautiful*.

Some folks say the pledge of allegiance isn't recited in school-but Monday everyone in the FES Don Hardin Gymnasium said the pledge as the colors were presented.

I can't speak for any other veteran, other than myself; but I was glad to see that.

Freedom indeed, is not free.

It comes with a high price that can be paid only in the blood of those willing to place themselves in harm's way.

Our nation lost 291,557 military personnel in World War Two in battle and lost another 113,842 in non-battle related deaths.

In the Korean conflict we lost 33,739 military personnel in battle and another 2,835 in non battle related deaths.

In Vietnam we lost 47,434 military personnel in battle and another 10,786 in non battle related deaths.

In Desert Storm we lost 148 military personnel in battle and an additional 235 in non-battle related deaths.

From 2003-2012 we lost 4,486 military personnel and we've lost almost 2,200 more in Afghanistan thus far.

Those are fairly sobering statistics.

Another sobering statistic comes to us from the Veterans Administration.

"There are approximately 18 veterans who commit suicide each day."

That's hard to read, I would imagine for the average reader.

The Veterans Administration also tells us that on any given night in this great nation of America there are 76,000 veterans living on the streets! Imagine that. 76,000 men and women who put their own freedom; their very lives at risk for the rest of the nation and tonight, approximately 76,000 of them will have no home in which to lay their weary head.

If that doesn't make you want to scream, then

you're not worthy of living in a democracy or ever having the opportunity to enjoy any freedom, in my opinion.

It is no secret that I have been a vocal opponent of the Iraq War since it began.

I thought it was a cruel blunder by cruel leaders of this sweet and giving nation of ours.

It is politically correct to parrot the phrase "Support the Troops!" But supporting policies that send our children, our fathers and mothers, our loved ones, our classmates, half way around the world to destroy the cradle of civilization at the whim of tools of the Military Industrial Complex based on non-truths (weapons of mass destruction that did not exist) while placing their lives in harm's way for an unclear mission is, in my opinion a war crime unto itself.

Drug task force head fired

The head agent of the Buffalo Trace Gateway Narcotics Task Force was fired Nov. 7 at a special called meeting of that entity's board of directors, when allegations of missing money surfaced during a spot audit of the agency.

Tim Fegan, a veteran drug task force agent and law enforcement officer with the city of Maysville, had his employment terminated during a two and one-half hour meeting of the BTGNTF board of directors at Fleming-Mason Energy in Flemingsburg in the morning of Nov. 7.

Nicholas County tax payers saw \$2,500 of their money donated to Fegan who came to fiscal court meetings this year asking for support, according to Nicholas County Judge-Executive Kenny Lyons.

Judge Lyons said he

was aware of Fegan's termination but was not aware of many details regarding his termination or the ongoing investigation.

Mason County Sheriff Patrick Boggs, the Chairman of the Board, along with Maysville Chief of Police Ron Rice, conducted the audit recently and found discrepancies in the accounting regarding the task force funds.

Boggs was out of town Nov. 8 and was not scheduled to return to Mason County until Nov. 15, according to officers with the Mason County Sheriff's Dept., who said Sheriff's Boogs' departure had been planned for months in advance, before the recent events surfaced.

Boggs was thus unable to comment, though Rice did, briefly.

"I can't confirm nor deny any amounts as far as discrepancies we discovered on the spot audit," Major Rice said.

"I wish I could say more, but with Officer Fegan being a law enforcement officer who was sworn in with the city of Maysville-that makes it a personnel matter."

Board members present at the special meeting said "good discussion" was held during the meeting.

Nicholas County Sheriff Jeff Sidles was present during the meeting also as a representative of the Nicholas County Fiscal Court but was unavailable for comment as the Carlisle Mercury was preparing to go to press.

The city of Carlisle also contributed to BTGNTF at the request of Fegan, according to multiple sources who serve with the BTGNTF.

The representative for Carlisle was not present at the meeting of the board of directors when Fegan's termination was discussed, according to several others who were present at the meeting.

A special investigation into possible criminal charges is being launched by Kentucky State Police personnel and it is believed by veteran law enforcement officers that a special investigations unit, possibly involving officers with the DESI (Drug Enforcement special Investigations) will be leading that investigation.

Some area law enforcement officers have expressed an opinion that the recent chain of events will damage the criminal cases-past-present and some future, being presented to a future grand jury, due to Fegan's fall from grace. His termination may cause "serious" problems with convictions and the overturning of convictions as well as cases scheduled to go to this month's and pending-months grand juries across the BTGNTF area, according to veteran area law en-

forcement officers.

Commonwealth Attorney Kathryn Hendrickson said she could not comment on any ongoing investigation, including Fegan's.

The counties served by the drug task force typically include Bath, Bracken, Fleming, Mason, Montgomery, Pendleton and Robertson County.

Fegan, however, reached out to Nicholas County officials this year as well as Carlisle city officials who both provided funds for the task force.

Major Rice said the monetary discrepancies involved several recent months of 2012 but noted that those months were the only ones involved where discrepancies were found, although the future investigation will likely be wider and might uncover additional discrepancies.

Fleming County Judge-Executive Larry

Foxworthy said he and members of the Fleming County Fiscal Court had questioned funds they paid to the task force for the last three years, but were assured that the funds were used strictly in accordance with task force needs and law enforcement.

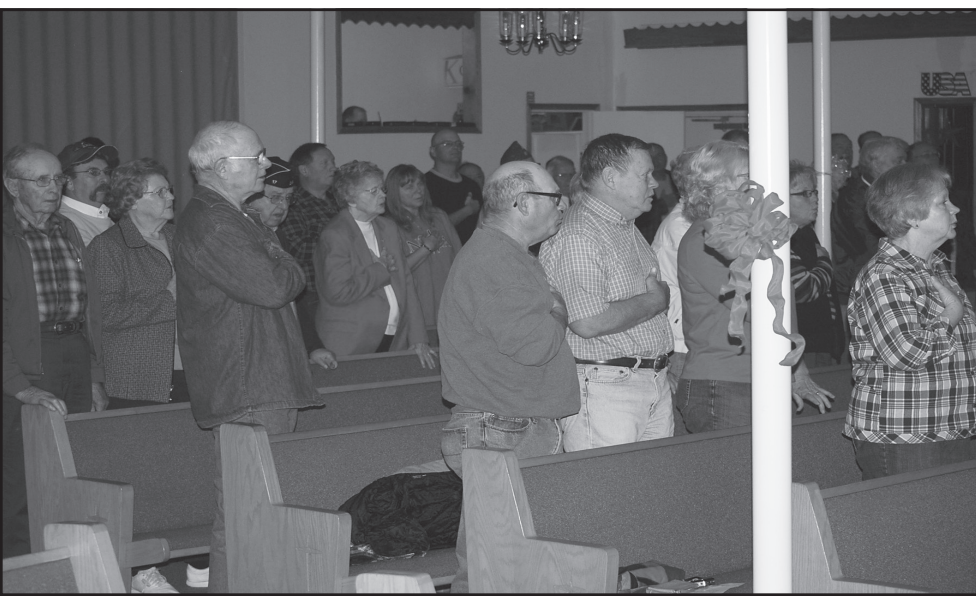
Those assurances however were largely made by Fegan.

Many have commented that Fegan was a tireless officer who helped protect citizens of the community from dangerous drug activity and substances and was dedicated to that job. Major Rice said the audit discrepancies were in "no way" connected to any previous or other cases or activities Fegan was involved in, to his knowledge.

The Mercury will continue to cover the events surrounding this story as they become additionally known.

The Kentucky State Police is continuing its investigation into a missing person complaint in Nicholas County. W.H. Sullivan, a resident of Hickory Ridge Road, was last seen leaving a friend's house in the Little Rock community in Bourbon County at approximately 9:00 p.m. Sunday night, November 3rd, traveling toward his home in Nicholas County. The 79-year-old Sullivan did not return home and has not been seen since his disappearance 12 days ago.

Officers and members of the Carlisle Rotary Club received special recognition last week. District Governor Jerry Blanton presented the Rotary International Presidential Citation to President Bob Garvin during the governor's official visit to the club.

The City of Carlisle will have a new police chief next month. The City Council has unanimously passed a resolution appointing Sergeant William Allen Earlywine to the position, effective December 20, upon the retirement of current Chief Earl "Sam" Finch.

1997

A proposed parking ordinance isn't meant to penalize citizens, say members of City Council. "I'm talking about the ones who leave their cars parked for 30, 60 and 90 days. Darbo, who resigned his post as a Nicholas County High School math teacher in March of 1991, was apparently informed by letter in May of this year that The Education Professional Standards Board was to hold a hearing on October 6 to determine whether Darbo's teach-

ing certificate should be revoked upon allegations of "immoral conduct."

Besides a new high school, parents and teachers filled school board chambers Monday night to lobby for the employment of additional school aides in the systems primary school program. Although the board could not actually hire new aides, board members agreed to amend the 1993-93 elementary school budget to cover the salary of "employee instructional assistants 1" at a cost of \$8,646.

Nicholas County Fiscal Court signed a new order it received from the Kentucky Natural Resources and Environmental Protection Cabinet. By signing the document, the court agreed to pay \$3,000 in penalty fines and offer \$57,000 as a letter of credit for sanitary landfill violations.

Carlisle City council heard an annual auditor's report on the city's financial situation. Proctor W. Blair, certified public accountant, reviewed the city's books from the year of July 30, 1986 to June 30, 1987. He made the remarks at Monday's regular council meeting.

The Nicholas County Fire Board Committee has voted to purchase a new county fire truck. The committee took the action at its regular meeting Saturday. Members of the fire department have been raising funds toward

purchase of a new fire truck, however, the need to purchase a new truck increased with the department's main vehicle, a 1963 Ford Pumper, went out of commission about a week prior.

Jackets fall to district rival Fairview

Nicholas County ends season 7-5 for second straight year

Nicholas County's run in the postseason ended Friday night with a loss to Class A, District 8 Champion Fairview in the second round of the Class A State Playoffs. Host Fairview pulled away to defeat the Bluejackets 48-20.

State title contender Fairview remained undefeated, moving to 12-0. The Eagles stand along as the state's only undefeated Class A football team.

Nicholas County, following the season-ending loss, exited the season 7-5. The Jackets fell to Fairview after defeating South Floyd 35-28 on the road in the opening round of the Class A State Playoffs.

Nicholas County, under the direction of veteran head coach Robert Hopkins, compiled a 7-5 record for the second straight seasons. The Jackets have enjoyed three consecutive winning seasons under Hopkins.

Senior running back Elijah King was the of-

fensive catalyst for the Eagles. King rushed nine times for a season-high 236 yards and three touchdowns. The speedy King scored on three 50-plus yard runs. King scored on jaunts of 75, 57 and 55 yards.

King, however, wasn't the only Fairview running back to produce. Fairview flourished on the ground. Eagles' fullback Chris Brewer, halfback Devon Turner and receiver Mason Rutherford each scored one touchdown apiece.

Fairview used quick strikes to fend off hard-charging Nicholas County. The Eagles scored seven touchdowns, reaching paydirt on scoring efforts of 30 or plus yards on all seven touchdown-ending drives.

Brewer added a defensive score for the Eagles when he returned an interception 60 yards for a touchdown in the fourth quarter.

Fairview led 16-0 before the Jackets arrived on the scoreboard. Nicholas County answered with a long 71-yard scoring drive that took seven minutes off of the clock. But the Jackets never got closer.

Senior running back Austin Allison led the Nicholas County offense. Allison rushed 35 times for 198 yards and three touchdowns. Allison scored on runs of 5, 6 and 14 yards. A workhorse, Allison led the Nicholas County offensive effort throughout the season.

Nicholas County and Fairview battled for the second time this season. When the two teams met during the regular-season, Fairview defeated the Jackets 36-7.

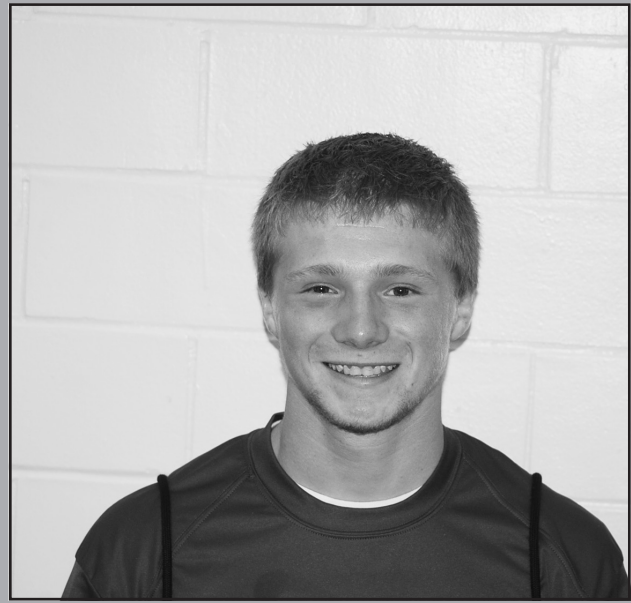
During the regu-

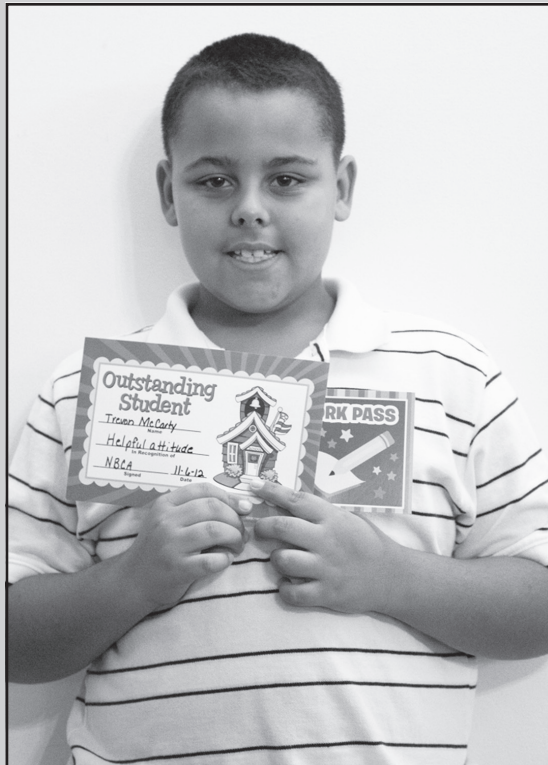

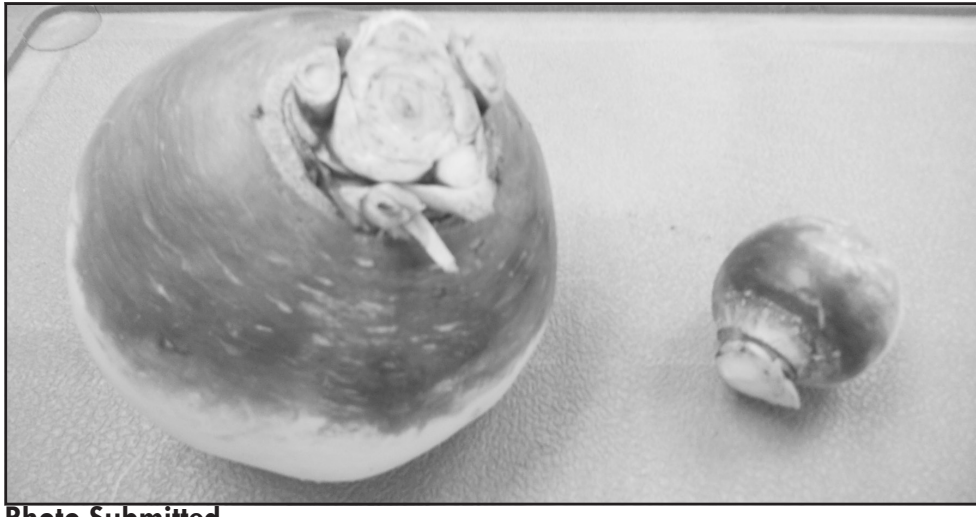

Kenny Lyons Discusses Funds and Taxes at Brown Bag Forum

Nicholas County Judge-Executive Kenny Lyons spoke to several members of the Carlisle and Nicholas County Chamber of Commerce about Nicholas County's annual budget at their regular Brown Bag meeting last Friday.

To make them easier to understand, Lyons presented the numbers in the form of a chart.

Lyons explained to everyone about the funds that the county is currently in charge of.

"The General fund is what everyone looks at," said Lyons. "The general fund is currently \$1,125,911, but that money is for projects around the county that need improvement. Also, \$267,961 has to come out for the Jail Fund."

Lyons went on to discuss the jail fund, saying that it costs \$32 per day to board an inmate.

"There's currently \$1,045,089 in the county road fund. I know some people think that this is a very decent amount, but they don't realize the restrictions on this money. The funds in this account can only be used for repairing and maintaining roads and nothing else, and those kinds of projects can be very expensive and can cost approximately \$54,000 per mile to fix county roads."

Addressing concerns over the funds within the county, Lyons cleared the air of some confusion.

"We are not a business, so our goal is not to turn a profit," said Lyons. "We run a county. We try to break even. Our job is to provide everyone in the county with their needs and address their concerns."

A subject on many citizens' minds is the concern over mandatory trash pickup, which Lyons discussed.

"A lot can be done as far as recycling in Nicho-

las County," said Lyons. "With mandatory pickup, we would still have a recycling center. We pay \$600 a year for pickup of a dumpster. With recycling, this amount is \$60,000 per year."

The salary of the Judge-Executive, which was mentioned at the meeting was another of Lyons' speaking points.

"The total salary of Judge-Executive is \$128,088 per fiscal year," said Lyons. "But several things have to come out of this. The salaries of the payroll clerk and secretary have to be paid out of this amount as well as travel, training and office equipment. After everything comes out, the actual salary is only \$70,064. This amount is based on population and years of service and is set by the state of Kentucky."

Lyons also discussed the tax rates for Nicholas County.

"People ask me whether our tax rate is low or not," explained Lyons. "In com-



parison, Bracken County's tax rate is much bigger and they have about the same population that Nicholas County does. Their tax rate is currently 68 cents per \$100, while ours is 13.5 cents per \$100. Over ten years our tax rate has increased 10% each year."

In conclusion, Lyons outlined his goals for Nicholas County and the future.

"We can survive with what we have right now, but we don't have the money to move forward at the moment," explained Lyons. "We're paying our

bill and we're in better shape than other counties. I want us to grow, but I still want us to maintain our rural lifestyle. I'm proud of Nicholas County and would like us to continue to prosper."

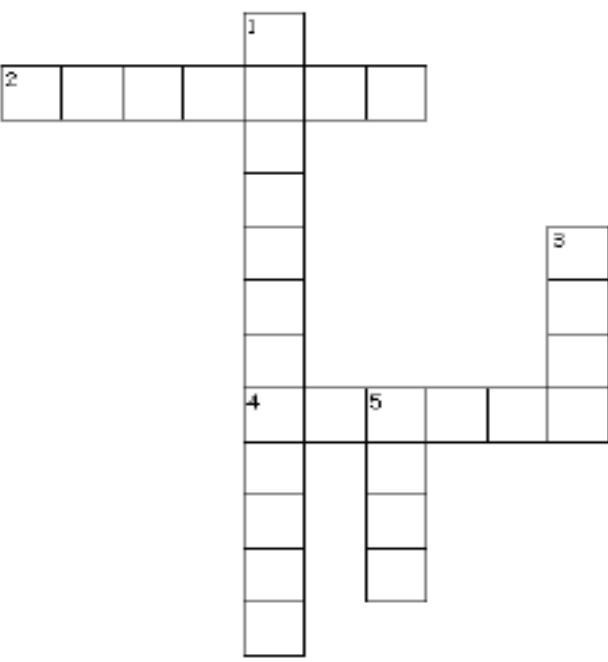

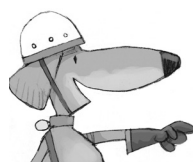

Fire bill dispute discussed

Members of the Nicholas County Fire Board discussed the purchase of a new fire truck and a dispute over their fire bill to the City of Carlisle at last Thursday's meeting.

Legal matters and the purchase of another fire truck were among the many issues discussed at last Thursday's regular meeting of the Nicholas County Fire Board.

With the insurance money received as a result of the fire truck that was severely damaged while responding to a series of fires, the county fire department determined that the purchase of a new fire truck would be greatly needed.

The total amount received by the fire department was \$97,225.43, minus a \$1,050 tow bill.

A motion was made by Andy Whirlles to accept the price of the truck. Steve Minton seconded. The motion passed.

In regards to the truck, a motion was made on the October 24 meeting to sell the truck with an option to rejects all bids.

It was mentioned that the option to fix the damaged truck was cheaper, but would take an extended period of time.

It was estimated by Fire Chief Doug French that the repairs on the truck could take approximately six to eight months. With the current season, it was deemed that this was an unacceptable amount of time.

A motion was made by Andy Whirlles for the Fire Department to keep the wrecked truck to explore more options on how to deal with it. The motion was passed unanimously after a second by Steve Minton.

In the matter of a new fire truck, Doug French reported that he had found two trucks that would meet the needs of the department.

The first truck is a 2006 two-door model in California with approximately 20,000 miles for \$122,000. The truck has a one-year major component warranty with a \$3,000-\$12,000 warranty for repairs. The sellers of this truck stated that whoever purchases the truck would be reimbursed for travel expenses, including food, hotel and plane tickets, but would not be reimbursed if they did not buy the truck.

The second truck discussed was a newer two-door model, 2012, with 2,700 miles for \$189,000. The truck has a one-year bumper to bumper warranty and a five year warranty on all other repairs.

While the four-door model was agreed to be the best truck, there was some concern over whether or not the department actually needed a four-door truck.

"I do see a big benefit with a four-door truck for the department," said Fire Chief Doug French. "Also, when I talked with the people in California, they were initially asking a lot more for the truck. I jokingly asked for \$125,000 and they lowered their price to \$122,000 because it had been sitting a while."

Mayor Kevin Booth in regards to a bill over the Carlisle City Fire Department.

This matter caused quite the discussion among members of the fire board.

According to the fire board members, the mayor has stated that Judge-Executive Kenny Lyons promised reimbursement of expenses upon signing of the Mutual Aid Agreement. According to sources, the Mutual Aid Agreement has yet to be signed.

"It would be best for everyone if we could all sit down and work this out in a civilized manner," said Jay Moreford.

It was also said by the members of the fire board that they had received word from the Carlisle City Office that Carlisle City Fire Chief Jim Biddle was treated disrespectfully, an alle-

gation that several members of the fire board denied, insisting that they even commended him on a job well-done.

Fire board members Jay Moreford, Steve Minton and Tracey Brown stated that they will attend the November 12th meeting of the Carlisle City Council. Further details on this case can be found within the article on the meeting.

A motion was made by Andy Whirlles to adjourn the meeting shortly after 10 pm. A second to the motion was made by Steve Minton.

The next meeting of the Nicholas County Fire Board will take place on December 4th at 7pm.

Beechburg man killed during police shooting

A Beechburg man was killed during a police shooting, which came on the heels of an alleged domestic dispute Nov. 8 at the man's home.

James Hay, 50, of Beechburg Road, KY 3303, died as a result of gun shot wounds inflicted by police who say they had tried for over an hour to reach a peaceful resolution but were forced to engage Hay with gunfire when he brandished a weapon and pointed it at them.

"Officers pleaded with Mr. Hay for approximately an hour to put down his weapon," a press release issued by the Kentucky State Police reads. "Mr. Hay refused to comply and threatened the officers with the firearm at which time the officers shot and fatally wounded Mr. Hay."

Witnesses say they distinctly heard three gun shots and multiple sources in law enforcement, some of whom were on the scene that day, indicated three shots had been fired.

It remains unclear to this reporter if Hay fired his weapon or if it were loaded.

It does appear from

multiple sources that it was Hay who initially made the call which led to police arriving.

All officers on the scene and those involved in the ongoing investigation said they "could not comment" on specifics of the shooting until the investigation was completed.

A special investigation led by Lt. J.W. Gibson, of the Ashland KSP Post remains open and ongoing.

Lt. Gibson was reluctant to discuss any aspect of the case due to the investigation having not been completed.

He did seem to indicate information regarding a veteran KSP Officer with "19 years" of experience may be the officer, or one of the officers, on the scene who discharged his weapon after feeling his life was in danger as were those of his fellow officers and perhaps neighbors who reside nearby.

Fleming County Sheriff Scotty Royse initially responded to the scene with three deputies: Arnold Dodge, Tyler Rushing and Jody Gray.

Sheriff Royse arrived at the James Hay-Kay Bivens home at approximately 3 pm that day.

Deputy Gray was not at the immediate scene when the shooting oc-

curred, according to Royse, who with Rushing and Dodge, remains on something akin to tactical leave-though he is still performing administrative duties.

Sheriff Royse and Deputy Rushing had returned to the Fleming County Sheriff's Office on Tuesday Nov. 13.

Several Kentucky State Police Officers responded to the scene at Sheriff Royse's request when Hay initially displayed a weapon.

Sources indicate the weapon that Hay brandished was a bolt-action rifle-but no officer on the scene would confirm nor deny this.

Officers were able to communicate with Hay and Bivens, who Hay was living with and had been for several years. Bivens was able to leave the scene uninjured before the shooting occurred, according to

KSP Information Officer Endre Samu.

A daughter of the couple arrived at the scene after school and with her mother was kept at the end of the gravel lane which led to the Bivens-Hay home. An unidentified officer interviewed Bivens and her daughter at the end of the lane.

"She was not present when the shots were fired," Trooper Samu said of Bivens.

The lane leading to the home was guarded by Kentucky State Police Trooper Thurman Paige and Sgt. Jason Townsend following the shooting and they were at the location to preserve the integrity of the shooting scene.

As many as eight other KSP Officers were present at the scene-some having arrived just after the shooting while it is believed as

many as four KSP Officers, possibly more, may have been present during the shooting, which occurred about one hour and 40 minutes after police initially arrived.

All individuals who have spoken with this reporter say the shooting was a "tragedy."

Trooper Samu stressed that fact and additionally expressed a feeling that the situation unfortunately escalated into something everyone wished could have been avoided.

"Mr. Hay acted in a manner in which the officers felt as if their lives were in danger," Trooper Samu said with sadness in his voice and added that at one time after police had arrived, Hay had been in the home when officers were at the scene, but had re-emerged from the home and was outside the home with a

firearm when the shooting happened.

It remains unclear at what distance hay was from officers or where a projectile or projectiles struck his body.

Fleming County Ambulance personnel were on the scene following the shooting but could not revive Mr. Hay.

Fleming County Coroner Gary Workman pronounced Mr. Hay deceased following the shooting.

An autopsy was conducted by forensic anthropologists with the Kentucky Medical Examiner's Office in Frankfort on Nov. 9, but Workman said it may be several days, even weeks, before the results are released.

The Gazette will continue to cover this tragedy as the information surrounding it becomes known.
